#### **? HOW TO USE**

The products can be used on most fabrics made of cotton, polyester, cotton/polyester, wool, silk and viscose. Ideal for removing stains that cannot normally be removed through mechanical washing, in order to decrease the rewashings.

Apply the product directly onto the stain. Let it work (\*), then wash with the cycle suitable for the type of fabric. In the case of particularly tough stains, repeat the operation and rub with a brush.

- DEG ACTION: 5-10 minutes;
- MULTI ACTION: 5-10 minutes;
- RUST ACTION: at least 15 minutes;
- STAIN ACTION: at least 15 minutes."
